- 2. Upcoming Electrical projects
  - a. Get bids for work (see below)

#### Removal of outlet in sofit

- If switch activated, disconnect wiring.
- Install appropriate cover.
- c. Onyx Court and street facing

### Front door lights

- Verify how these are wired
- Replace globe lights with electrically powered lights top portion outward facing, subdued lighting, bottom portion downward casting flood lights.
- Switch activated or dusk to dawn?
- d. Dune Court

### Porch and Front door lights

- Replace porch lights with switch activated LED lamps
- Replace carriage lights with electrically powered lights dusk to dawn lights (like service drive functionality) outward facing subdued lighting
- Current power allocation is one switch for both lights can this line be split so Front light is hardwired and porch light is switch activated
- e. Both Courts suggestion
  - Add solar powered, motion sensor lights to both courtyards to discourage trespassing and assist owners in nighttime navigation.
  - Suggested placement one on each corner of each pergola
- 3. Upcoming Painting project
  - a. Get bids for work (see below)
  - b. Research possible paint colors for siding and trim

#### 4. Bid considerations

- a. Electrical
  - i. Materials and labor cost for outlet removal all units
  - ii. Materials and labor cost for globe light removal and fixture installationOnyx Court and street facing
  - iii. Materials and labor cost replacement of porch lights Dune Court
  - iv. Materials and labor cost for carriage light removal and new fixture installation – Dune Court
  - v. Materials and labor cost for solar fixture installation both courtyards

- b. Painting bids areas of consideration
  - i. Materials and labor cost for prep work scraping, sanding, patching holes and cracks
  - ii. Cost of paint
  - iii. Labor costs to paint siding, trim, concrete walls (inside, outside), gates, metalwork on street entrances (do we include front doors in the bid).

### 5. Tentative timeline

- a. Electrical
  - i. Bids November 2024
  - ii. Select contractor December 2024
  - iii. Start date January or February 2025
- b. Painting
  - i. Bids February 2025
  - ii. Select contractor March 2025
  - iii. Start date April or May 2025 OR October 2025 (if bidding process takes longer
